4. Membership Report and Treasurer's Report Thelma Mott

Membership: Thelma reported the Association's total membership as of April 30, 2019 was 117 (44 life members and 73 annual). Three more annual members and one life member joined at the AGM.

Treasurer: Thelma reported that the Association is in a strong financial position, with a balance of \$4267.30 on April 30, 2019.

A copy of the membership and financial report is appended to these Minutes.

#5. Social Convenor's Report Dick Tindal

There is not a lot to report on this year, as our activities throughout the year are predictable. The coffee gatherings are most popular and will continue.

The September 19th hole held at The Landings is always well attended. Another lunch at the Golf Club may be scheduled later in the fall (as in previous years).

If members would like to organize other events, Dick will be happy to publicize them.

Dick reminded members that the Association website (slcretirees.weebly.com) is a regularly updated source of information, thanks to Ron Kelly, Webmaster. Ron is doing an excellent job and posts many

photos. Our members should visit the site often, are encouraged to comment on items, and to use the website as a way of connecting with members who are far away or don't usually attend our events.

6. Report on Association – College MOU meeting

Dick Tindal & Janine Foster

Dick noted that to date the MOU meetings have been somewhat frustrating because of the slow progress on items. Topics discussed at the meeting were:

- The Association asked for Alumni cards for retirees, to be used to access benefits such as use of the library and free parking. The College was advised by IT that creating the cards would be very expensive. The College wants to determine what benefits might be given, to justify the cost of producing the cards.

Access to AllNotes was requested for our members. This may be looked at for the Retiree Executive.
Some College events are open to retirees in the spring/early summer. Announcements are made by email to members, but the Association needs to be informed of these events more consistently.
We need a better connection with H.R. so that people who announce their plans to retire can receive information about our Association well in advance. The College's preoccupation with privacy rules has made sharing of information a continuing challenge.

-Once again, possible Professor Emeriti's recognition was raised. The College might study this again.

One of the MOU meeting items concerned the use of retiree donations and Janine Foster, Manager Alumni Relations & Annual Giving, was in attendance to address this issue.

Janine first reminded retirees that Alumni membership is offered to all at retirement.

Retirees have donated \$180,416 as gifts. This has allowed 30 student bursaries to be given across all three campuses. A Retirees Fund received 138 gifts since 2014 which have been combined with a Library Archive Fund to provide for \$14,000, to commence an archiving project. Some of the money donated goes to Operational Funds, such as the Nursing Student Initiative Fund; Music Theatre Performance Fund; Extraordinary Learning Fund; and Emergency Funds.

Janine thanked Dick for the most recent retiree column in Voyageur magazine. The most recent edition was very popular with readers, trying to identify folks in old photos.

NEW: slccurrents.ca - is a new platform for Alumni. Retirees can join to connect with former students, or former co-workers. Janine encouraged all to join.

Janine provided Alumni flyers and brochures for those attending.

#7. Amendments to Association Constitution Pennie Carr-Harris

A current copy along with suggested changes is posted on our website. All were asked to view this document prior to this meeting. Items are:

1. Section 2.0 referred to a Retiree Association office and address at the college which no longer exist, so the section is being removed.

- 2. Section 2 changes the fiscal year to run from May 1 to April 30.
- 3. Section 4.5.5 refers to a college facilitator assisting with the Association website, which is now maintained entirely by us, under Webmaster Ron Kelly.
